TRADING HALT – FLINDERS MINES LIMITED (ASX: FMS)

Pursuant to ASX Listing Rule 17.1, Flinders Mines Limited (Flinders) requests that ASX grant a trading halt of its securities effective immediately, pending release of an announcement regarding the appeal hearing in the Appellate Court Number 18 (City of Chelyabinsk), Russian Federation. The appeal relates to the Scheme Implementation Agreement between Flinders and Magnitogorsk Iron and Steel Works OJSC dated 25 November 2011.

Flinders requests that the trading halt remain in place until the earlier of Flinders making that announcement, or open of market on Friday, 1 June 2012.

Flinders confirms that it is not aware of any reason why the trading halt should not be granted.
