A\$3m was drawn on 22 March 2019 and was due on 30 June 2022. This loan was varied on 30 June 2022 where a repayment of \$2m was made, split into \$0.073m interest and \$1.93m principal. The remaining balance of \$1.3m is due on the earlier of 31 December 2022 or any shortfall or withdrawal payment from BBI Group Pty Ltd (a related party of the major shareholder) due under the provisions of the Pilbara Iron Ore Project Farm-In Agreement.
