1. Unsecured A\$3.0m loan facility provided by PIO Mines Pty Limited, a related entity of the major shareholder, TIO (NZ) Limited, at an interest rate of BBSW +2% pa. A\$3m was drawn on 22 March 2019 and was due on 30 June 2022. This loan was varied on 30 June 2022 where a repayment of \$2m was made, split into \$0.073m interest and \$1.93m principal. The remaining balance of \$1.3m was paid in October 2022 upon receipt of the termination payment received from BBI Group Pty Ltd (a related party of the major shareholder), which was due under the provisions of the Pilbara Iron Ore Project Farm-In Agreement.
